Notice Regarding Acquisition of Own Shares Through Off-Auction Own Share Repurchase Trading System (ToSTNeT-3)

(Under the provisions of the Articles of Incorporation of Canon Inc.
pursuant to paragraph 2, Article 165 of the Companies Act of Japan)

Canon Inc. passed a Board of Directors' resolution dated January 29, 2026, to acquire its own shares under Article 156, as applied pursuant to paragraph 3, Article 165, of the Companies Act of Japan, and as a part of this resolution, has determined a specific method for a portion of the acquisition of own shares as follows:

1. Method of acquisition

At 8:45 a.m. on March 11, 2026, a consigned purchase order will be placed with the Tokyo Stock Exchange Trading Network Off-Auction Own Share Repurchase Trading System (ToSTNeT-3) at the closing price (including final special quote) of 4,473 yen for today, March 10, 2026 (no changes to other trading systems or trading times will be made). The purchase order will apply only to the specified trading time.

2. Details of acquisition

(Note 1) No change will be made to the number of shares specified above. However, depending on market trends and other factors, a part or all of the acquisition may not be carried out.

(Note 2) The acquisition will be made on the basis of sell orders corresponding to the number of shares scheduled to be acquired.
